1. **Ordinance LC17-17: Impervious Cover.** An Ordinance to amend Kent County Code, Vol. II, Chapter 205, Zoning, as amended by revising Article V, AC-Agricultural Conservation District, §205-51, Coverage; Article VI, AR –Agricultural Residential District, §205-67, Coverage; Appendix 205:A1, Agricultural Conservation Matrix; and Appendix 205:A2, Agricultural Residential Matrix in order to increase the permitted impervious coverage for AC and AR zoned properties outside of the Growth Zone Overlay District from 20 percent to 25 percent.
