What is the overall deductible?	Network: EE Only \$5,000; EE+ Family \$10,000. Out-of-Network: EE Only \$5,000; EE+ Family \$10,000. <i>Inform your healthcare provider that deductible is paid by Kent County through HRA billed by Aetna.</i>	Generally, you must pay all of the costs from providers up to the deductible amount before this plan begins to pay. If you have other family members on the policy, the overall family deductible must be met before the plan begins to pay. Health Reimbursement Arrangement (HRA) is available that works with your medical plan, as described in your employer's Summary Plan Description.
Are there services covered before you meet your deductible?	Yes. In-network Preventive care, routine eye exam, prescription drugs and services with copayments are covered before you meet your in-network deductible. The out-of-pocket limit is the most you could pay in a year for covered services.
