What is the overall deductible?	<u>Network</u> : EE Only \$5,000; EE+ Family \$10,000. Out-of-Network: EE Only \$5,000; EE+ Family \$10,000. Inform your healthcare provider that deductible is paid by Kent County through HRA billed by Aetna	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the policy, each family member must meet their own individual <u>deductible</u> until the total amount of deductible expenses paid by all family members meets the overall family deductible. Health Reimbursement Arrangement (HRA) is available that works with your medical <u>plan</u> , as described in your employer's Summary Plan Description.
Are there services covered before you meet your deductible?	Yes. In-network <u>Preventive care, routine eye exam, prescription drugs and services with copayments</u> are covered before you meet your in-network <u>deductible</u> .	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply. The <u>out-of-pocket limit</u> is the most you could pay in a year for covered services. What is not included in the out-of-pocket limit?	<u>Premiums, balance-billing charges, health care this plan doesn't cover & penalties for failure to obtain pre-authorization</u> for services.	Even though you pay these expenses, they don't count toward the <u>out-of-pocket limit</u> .
